11 **A Bill to Update and Codify Cabinet Leadership**

13 Whereas, The University of Arkansas Associated Student Government
14 Cabinet has been under the leadership of the Chief of staff
15 and reporting Cabinet Leadership (Director of Policy,
16 Director of Programming, and Director of Marketing); and

17
18 Whereas, The importance of these roles has been shown in the past
19 two years as programming and policy initiatives have come
20 to fruition on campus; and

21
22 Whereas, The Code and Constitution Committee finds it important
23 that these positions be codified to ensure long-standing
24 representation in the ASG Cabinet; and

25
26 Whereas, The University of Arkansas and ASG have shown a growing
27 importance in Belonging and its role in the life of University
28 students, staff, and faculty; and

29
30 Whereas, The Director of Diversity and Inclusion currently is limited
31 by their ability to be fully representative of the needs of
32 diverse communities on campus, alongside their deputy
33 position; and

34
35 Whereas, There is an opportunity to increase the level of supervision to
36 the Diversity and Inclusion role by promoting them to
37 Cabinet Leadership.

39 Be it therefore resolved: The Associated Student Government Code be
40 amended to read,

42 "Title I. Executive Code: Section 9 – Duties of
43 the Executive Cabinet Leadership


- A. Executive Cabinet Leadership shall consist of a Director of Policy, Director Programming, and Director of Inclusion & Belonging.
- B. Executive Cabinet Leadership shall meet at least once (1) a week.
- C. All members of Cabinet Leadership shall report directly to the Chief of Staff.
- D. The Director of Policy shall oversee all policy initiatives taken on by the Executive Cabinet.
- E. The Director of Programming shall oversee all programming initiatives taken on by the Executive Cabinet.
- F. The Director of Inclusion & Belonging shall work to ensure that all Executive Cabinet programming and policy is working in the interest of all students and promoting a more equitable campus.
- G. All three Cabinet Leadership positions will manage one-on-one meetings with assigned cabinet members as outlined by the Chief of Staff.
- H. The ASG Secretary, or designee, shall maintain an open invitation to all Cabinet Leadership meetings.”


